

REGULAR SESSION

December 18, 2006

The Union County Board of Supervisors met in regular session on Monday, December 18, 2006. The meeting was called to order at 9:00 a.m. with the following members present: McCann, Irelan, Turner, and Brown. King was absent.

AGENDA: Motion by Turner and seconded by Irelan to approve the agenda. All voting aye, motion carried.
