

The Union County Board of Supervisors met in regular session on Monday, August 20, 2007. The meeting was called to order at 8:00 a.m. with the following members present: Brown, Ireland, Riley, McCann, and King.

AGENDA: Motion by McCann and seconded by Ireland to approve the agenda. All voting aye, motion carried approved.

MINUTES: Motion by Riley and seconded by Ireland to approve the August 13, 2007 minutes. All voting aye, motion carried.

OPEN FORUM/BOARD DISCUSSION: No comments were received from the public.

ENGINEER: Scott Nixon, County Engineer, presented the weekly maintenance and activity report, spray map, and discussed the possibility of building a bridge on Squirrel Ave (Sec 12 of Sand Creek and Sec 7 of Pleasant Townships). **Purchase Equipment Agreement:** Motion by Riley and seconded by McCann for the Chair to sign a purchase agreement from Ziegler, Inc. All voting aye, motion carried. **Utility Permit -** Motion by Brown and seconded by Ireland to approve the utility permit for Southern Iowa Rural Water Association to install 1" rural water line across 170th Street in Section 11, Union Township. All voting aye, motion carried.

PUBLIC HEARING - NAMING A PRIVATE ROAD: The public hearing on naming a private road opened at 10:00 a.m. No comments were received by the public, the Auditor's Office, the Supervisors, or the Engineer's Office. The public hearing closed at 10:07 a.m. Motion by Brown and seconded by McCann to name a private lane in Sec 33 of Dodge Township to Wildlife Lane. Roll call vote: McCann, aye; Brown, aye; Riley, aye; Ireland, aye; and King, aye. Motion carried.

EMA PART-TIME POSITION: Roger Nurnberg, EMA Coordinator and Gary Clear, EMA Chairman, discussed the part-time position (10hrs per week for 50 wks) with the Board. The Board does not support a permanent part-time assistant position.

NUISANCE ORDINANCE: Tim Kenyon, County Attorney and Louis Boeckman, County Sanitarian, discussed the County's nuisance ordinance with the Board.

HOMESTEAD/MILITARY DISALLOWANCES AND APPLICATIONS: Motion by Brown and seconded by McCann to accept the 254 New Homestead and Military Applications and 246 Homestead and Military Disallowances as presented by County Assessor, Gene Haner. All voting aye, motion carried.
