PUBLIC HEARING – ESTABLISH LEVEL B ROADS: The public hearing on establishing Level B roads opened at 9:00 a.m. No comments were received by the Board of Supervisors, the Secondary Roads Department, or the Auditor's Office. The public hearing closed at 9:12 a.m.

ESTABLISHING LEVEL B ROADS RESOLUITON: Motion by Turner and seconded by Irelan to approve **Resolution #27 FY04-05** – Whereas, Union County desires to classify certain roads on the area service system in the County to provide for a minimal level of maintenance; and Whereas, the Board of Supervisors of Union County, after consultation with the County Engineer, has the authority to designate certain roads within the County as Area Service “B” roads pursuant to Iowa Code Section 309.57; and Whereas, pursuant to Notice of Public Hearing duly published according to the Iowa Code, Public Hearing as held on the 6th day of December, 2004, at 9:00 a.m. in the Board of Supervisors room at the Union County Courthouse, Creston, Iowa to hear support and/or objections from the public on roads so designated. Therefore, Be It Resolved By The Board Of Supervisors On Union County that this County does hereby establish the roads described as an Area Service “B” road, with restricted access and a minimal level of maintenance. The alley that extends from Almond Ave (Maple St) east to Apple Ave (Oak St), between 241st (Jefferson) St and 242nd (Berwick) St, the alley that extends from Acorn Ave (High St) east to Almond Ave (Maple St), between 241st (Jefferson) St and 242nd (Berwick) St, the alley that extends from 243rd (Ambrose) St north to 242nd (Berwick) St, between Acorn Ave (High St) and Almond Ave (Maple St), all alleys are located in the area formerly know as Kent, in the NE $\frac{1}{4}$ of Section 18-71-31, (Platte Twp.) Resolution adopted this 6th day of December, 2004. Roll call vote: McCann, aye; Turner, aye; Brown, aye; Irelan, aye; and King, aye. Motion carried.

ENGINEER: Scott Nixon, County Engineer, presented the weekly maintenance and activity report and the November Rock Map.

CLAIMS: Motion by McCann and seconded by Brown to approve the handwritten claim to Union County Health Insurance for \$24,091.21. All voting aye, motion carried.
